Neuro Rehabilitation & Neurovascular Nurse Specialist for Children & Young People Neurology Department, RMCH August 2017 – Present

- Undertake clinical assessments and provide written reports to aid completion of 'Decision Support Tool' (health care assessment), CAF, Education/Health Assessment and EHCP, and DLA.
- Carry out therapeutic assessments (e.g. PEDI, Rancho Los Amigos, WeeFIM, WeeFAM), as required to deliver child focused nursing and therapeutic care.
- Support the Consultant Neurologist, ward and interdisciplinary teams in 'tri-partite complex' discharge planning ensuring this is effective, efficient and cohesive with community teams.
- Chair 'discharge planning meetings', 'team around child meetings' and weekly ABI grand round.
- Undertake Home visits to assess access to property/equipment needs to facilitate safe discharge, as required.
- Provide leadership, specialist advice and support to ward nurses and families in care of Child/YP with ABI and neurovascular disorders on a day-to-day basis in the clinical area.
- Work closely with the Education and Development Department and Neurosciences Advanced/Specialist Practitioners in providing annual divisional training in assessment of consciousness in Children & Young People.
- Review current divisional guidelines and update as required.
- Established a database, documenting children with a non-traumatic acquired brain injury that attended RMCH and use this data to consider future developments for the service.
- Provide line management to neurology specialist practitioner team.
